Campsite Vendor- Only one wheeled camping unit and one storage unit per campsite.

The applicant agrees to follow the Rules and Regulations of the Atwood Fall Festival Committee and the Muskingum Watershed Conservancy District. Any Violation may be cause for revocation of permit.

Upon acceptance, the exhibitor agrees to participate in the 2009 Atwood Area Fall Festival on Oct 2, 3 & 4, 2009.

Exhibitor agrees to abide by the Atwood Area Fall Festival Rules, and the Rules and Regulations of the Muskingum Watershed Conservancy District, (MWCD), and acknowledges receipt of copies thereof. Exhibitor understands that this permit is not a lease, but a permission to use certain conditional space at the Atwood Area Fall Festival. Exhibitor is not permitted to take additional space or move from assigned space.

Exhibitor agrees, in connection with space reserved and participation in the Atwood Fall Festival, to hereby agree to indemnify and forever hold harmless the Atwood Area Fall Festival and M.W.C.D. from and against all suits, claims, damages, or losses to persons and property sustained while upon Atwood Lake Park occasioned by any act, omission, neglect, or wrong doing of an exhibitor, his agents, or employees.
